ADVISORY REPORT

a.) Approval of Advisory Board Duties

- 2.) Members shall have the privilege of discussing Board business at any and all meetings.
- 3.) Members shall advise the Board upon the Board's activities.
- 4.) Encourage members to serve as examiners for the Journeyman and Master Exams
- 5.) Members shall serve as special enforcement officers <u>as requested by the Board's administrative office</u>.
- 6.) Advisory Committee Special Enforcement Officer duties include:
 - a. Conduct inspections and investigations of plumbing work and activities of employing entities as instructed by the Board;
 - b. Document and report all findings to the Board's administrative office
 - c. Provide evidence to findings in an administrative or legal proceeding initiated under the plumbing law by the Board.

Mr. Finley stated that he thought that this list of duties should and will be an ongoing list. Mr. Fabra agreed stating that changes may need to be made in the future, either by adding or removing duties.

INDIVIDUAL MEMBER'S REPORT

Mr. Linden Raimer thanked Mr. Barker for the wonderful job he and his staff have done.

Mr. Finley stated that NITC, the third party agency that developed the Journeyman and Master plumber exams, has reapplied for the ANSE accreditation. ANSE hired a company our of Florida that in turns selects people throughout the country, including Mr. Raimer and himself, to develop the criteria for the new test. This is currently in the process. Several industry people have been selected to review what has been done. At the conclusion of the review, a bank of questions will be made. Then it will be the State Plumbing Board's responsibility to select what is or is not important for our particular area.

EXECUTIVE DIRECTOR'S REPORT

Mr. John Barker asked the Board and Mr. Robein for clarification on the registering of apprentices requirement. Mr. Barker stated that the Administrative Code does not require that applicants for the Journeyman be indentured apprentices. At the previous Board meeting, it was suggested that letter be mailed out with the 2011 renewals explaining this requirement and Mr. Barker does not want the wrong information sent out. Mr. Finley suggested directing the question to Mr. Robein because this same question was brought up a few years ago and that at that time, the Board was accepting that it was not following the law the way it was written and there was no problem going to the mandatory requirement of apprenticeship training. However, he stated that that decision was made two years ago and that Mr. Robein should review it again. The Board recommended that Mr. Robein draft a letter to be mailed out with information regarding this requirement. Mr. Finley recommended pushing back the requirement date. Mr. Fabra seconded Mr. Finley's recommendation.

Mr. Barker asked Mr. Robein to research the ethics of those serving on the Board and being paid to provide continuing education. Mr. Barker stated that he does not believe it is a problem; however, he does think that those Board members probably need to disclose that information. Mr. Fabra stated that he felt that those Board members should simply excuse themselves from voting on issues concerning continuing education that are a conflict of interest. Mr. Robein added that they need to include this in their annual statement.

Mr. Barker informed the Board he has been approached by individuals/companies interested in making donations to the SPBLA. He asked Mr. Robein to please look into the legality of the Board accepting donations, monetary and otherwise.

Mr. Barker and Mr. Steve Yost previously spoke regarding an interest bearing account. Mr. Barker informed the Board that they will be looking into putting some money into an interest bearing account, possibly a savings account, and transferring the money as needed.

Mr. Barker discussed the topic of a gas fitter license. There is currently no statewide gas license, other than medical gas. Mr. Barker met with Mr. John Alario, Jr., Executive Director of the LP Gas Commission, and he informed Mr. Barker that provided the Board pursues the license through a safety avenue, neither Mr. Alario nor his staff will have any objections. Mr. Barker will also meet with Mr. Butch Browning, the Louisiana State Fire Marshal, regarding the same topic. He will inform the Board of the outcome of that meeting.
