ENFORCEMENT

a.) Informal Hearings

Edward Sugg- Mr. Sugg was cited for 4 counts of use of unlicensed personnel on January 24, 2012. SPBLA sent Mr. Sugg notice of this violation on January 31, 2012. He responded in writing stating that he had no knowledge of who the individuals on the jobsite were. After speaking with Mr. Sugg we sent him a request for him to come in for an informal hearing on Tuesday, May 22, 2012. Mr. Sugg appeared before Executive Director, John Barker, Enforcement Officer, Carl Barnum, and Administrative Staff Member, Lindsey Mayer. During the informal hearing Mr. Sugg continued to state that he did not know who the individuals were. Mr. Barker reduced his fine from \$2,000.00 to \$1,500.00. Mr. Sugg is on a payment plan, paying \$250.00/month for 6 months.

Amado Enamorado- Mr. Enamorado was cited on December 8, 2011 for doing master work without a license. SPBLA sent him notice of this violation on January 23, 2012. Mr. Enamorado responded in writing stating that he was doing work for a friend who is the home owner and he was operating the excavator. The Plumbing Board sent him notification that his violation still stands and he owes an enforcement fine of \$500.00. Mr. Enamorado then sent a letter in writing requesting an informal hearing. He appeared before Executive Director, John Barker, Enforcement Officer, Carl Barnum, and Administrative Staff Member, Lindsey Mayer. Mr. Enamorado stated again that he was working for a friend who was the home owner. Mr. Barker explained to him that the law stated that the home owner could work on his own property without license but could have no helpers. Mr. Barker reduced his fine from \$500.00 to \$300.0. Mr. Enamorado paid his enforcement fine in full.

a.) Jeremy Harris

Mr. Harris gave an update on the code revision. He said that the code committee was formed in 2009 and has been meeting since. Mr. Harris stated that it should be published within the next 2 months. After it is published there is a sixty day comment period. He said they are expecting both negative and positive feedback, but they will look at those as they come.
